Doug serves as co-chair of the Professional Discipline Committee of NYSBA Health Care Section and is a member of the Tulane University School of Law Criminal Law and Procedure "Boot Camp" faculty. He also served as a Chairman of the Board of Directors for the Island Harvest Food Bank and is a member of the Board of Advisors to the L.I.
