Eric C. Rubenstein successfully manages a diverse real estate transactional practice with specific emphasis on commercial leasing, acquisitions and sales, and mortgage financing and 1031 transactions. He personally closed the \$210M sale of Jericho Plaza, one of the largest one-site real estate transactions in Long Island history, as well as the \$190M sale of EAB (now RXR) Plaza, and a \$140M securitized leasehold mortgage with Lehman Brothers. For many years, he handled all of the financing and leasing at Jericho Plaza and RXR Plaza (comprised of more than 1,800,000-square-feet in the aggregate).

Eric is Of Counsel at Ruskin Moscou Faltischek, P.C., where he is a member of the firm's Real Estate and Health Law Departments. He is also a member of the Environmental, IDA & Municipal Development Incentives, Tax Certiorari & Condemnation, and Zoning & Land Use Practice Groups.

Eric then spent six years as in-house real estate counsel for a division of ABN AMRO Bank on Long Island and in New York City. For three years, Eric served on the Board of Directors and Executive Committee of Landmark on Main Street, Inc., a community nonprofit organization, which converted an elementary school in Port Washington, where he resides, into subsidized senior housing, daycare and afterschool facilities, and a theater.
